2. In view of the foregoing the following directions are issued in partial modification of notification dated 06.09.2024 only to the extent where applicable:

- 1. The **last date of submission** of application form by the applicant to his/her respective office **has been extended** from 13.09.2024 (Friday) to 20.09.2024 (Friday).
- 2. In offices where the DE vacancy in LDC has been **reported as zero**, the process of LDCE LDC to JA 2024 **stands closed** and no applications are to be accepted. In case applications have already been received, the same are to be returned to the applicant due to non-availability of vacancy.

- 3. The last date of Circle offices to send the requisite application forms and proformas of the applicants to the O/o CGCA has been extended from 18.09.2024 (Wednesday) to 23.09.2024 (Monday).
- 4. Only applicants who have completed three complete years of regular service as LDC in Telecom Accounts and have successfully completed their probation period (where applicable) and are between 18 to 60 years old as on 01.09.2024 are eligible to appear in the examination.
- 5. The tentative exam dates are still 30.09.2024 for Paper I and II and 01.10.2024 for Paper III.
- 6. The list of eligible candidates along-with allotted roll numbers shall be posted on the CGCA website on 25.09.2024 (Wednesday).
- 7. In offices where there is vacancy but no candidate is eligible or no candidate has applied by 20.09.2024, the exam process of LDCE LDC to JA 2024 shall stand closed.
- 8. All other conditions (not in conflict with this corrigendum) in Notification dated 06.09.2024 shall remain the same.
